



## Rules & Eligibility & Confirmation of Acceptance

### Rules and confirmation

This document (the “Agreement”) contains the rules for the Shining Star CLE 2025 competition (herein the “Competition”). When signed below, the document becomes an executed and legally binding agreement. The required Performance and General Venue Release is incorporated herein and made a part hereof by reference.

### Eligibility

You (referred to as you or “Participant”) must be a youth currently attending a high school in Ashtabula, Cuyahoga, Geauga, Lake, Lorain, Medina, Portage, Stark, Summit or Wayne counties and in the 9<sup>th</sup>-12<sup>th</sup> grade, (including home-schooled students) with a 2026-2029 graduation date. Previous 1<sup>st</sup> place winners are not eligible to audition or compete.

All Participants must be available to compete at the Semifinals on Sunday, August 3, 2025 as well as perform at The Finals on Sunday, September 7, 2025.

### What to have prepared for the live auditions/Semifinals

Bring copies of your signed *Rules & Eligibility* and *Performance & General Venue Release* forms (available online). You and a parent/guardian must complete and sign our required forms outlining terms and conditions. If needed, these forms will be available at auditions.

### What to sing at auditions

Any song performed a capella (without music), with piano accompaniment or personal instrument usage is preferred, but recorded accompaniment is allowed. If you make the Semifinals, you will be able to provide a music track background. The song you choose will likely be the song you perform throughout the length of your journey in the Competition (subject to the sole discretion of the artistic director). In order to avoid repetition, the top ten finalist songs from the previous year are excluded from the current competition. Please do not plan on singing any of the following songs from last year: *Quiet* (Natalie Weiss), *The Toreador Song* (Carmen), *She Used to be Mine* (Waitress), *I Know Where I've Been* (Hairspray), *My Future* (Billie Eilish), *Out There* (The Hunchback of Notre Dame), *Middle of a Moment* (James and the Giant Peach), *When We Were Young* (Adele), *Heart of Stone* (Six the Musical), *Hero* (Mariah Carey), *World Burn* (Mean Girls), *My Grand Plan* (The Lightning Thief).

## Participant hereby represents and warrants that

- A. I am a legal resident in the United States, with the unrestricted right to work for any U.S. employer and reside in the United States;
- B. Any and all material or content that I perform during the Competition, including performances, intellectual property, and any other materials related to the foregoing (collectively “Submitted Material”) are the result of my own initiative, and I have the exclusive and unconditional right to submit the aforementioned in connection with the Competition. No other person has collaborated with me in connection with my Submitted Material or otherwise has any other rights or interests therein. For the avoidance of doubt, I further represent and warrant in connection with any Composition, joint work, or any other music and/or song(s) I submit to Mandel JCC, perform or otherwise use in connection with Mandel JCC or the Competition (whether for approval for use in my performances or in connection with the Submitted Material) that: (i) either I am the creator of the Composition or such Composition is in the public domain (if any Composition, Joint Composition, or any other music and/or song (including any underlying element thereof) that I submit to Mandel JCC is, in whole or in part, in the public domain, I will notify Mandel JCC in writing of such public domain material); (ii) no third party has any rights in or to the musical composition(s) and/or recording(s) of any such Composition, Joint Composition, and any other music and/or song(s) submitted by me to Mandel JCC; (iii) no payment, credit, acknowledgment contribution, monies, remuneration, or any other consideration of any kind is required or owed to me, and/or any third parties for the use of such Composition, Joint Composition, and any other music and/or song(s) in and in connection with the Competition; and (iv) I own or have obtained all rights, including without limitation synchronization and master rights, necessary for Mandel JCC to exploit the Submitted Materials inclusive of such musical composition(s) and/or recordings of any such Composition, Joint Composition, and any other music and/or song(s) (in whole or in part), in any and all media, now known or hereafter devised (including, without limitation, in and out of context promotions, advertising, publicity, merchandising, and all subsidiary, allied and ancillary rights in or in connection with Mandel JCC) throughout the universe in perpetuity and I hereby grant to Mandel JCC, its licensees, designees, contractors, and assigns, the worldwide, irrevocable, royalty-free, and perpetual right to record, reproduce and publicly perform any such Composition, Joint Composition, and any other music and/or song(s) (in whole or in part) in and in connection with use, presentation or distribution of any or all of the foregoing rights granted will not infringe upon, violate or misappropriate any rights of any third party, including, without limitation, copyrights or other intellectual property rights, and such rights may be exercised without any costs to Mandel JCC, or in any way limiting the waivers and releases set forth in this Agreement, I waive any and all claims to royalties of any kind, whether accruing now or in the future, from Mandel JCC, or any of its licensees, designees or assigns, for the use of any such Composition, Joint Composition, and any other music and/or song(s) (in whole or in part), including without limitation any applicable copyright, public performance, mechanical and synchronization royalties.

If you and/or your friends, family members, or anyone else accompanying you to the audition or performance do not wish to be photographed, **please do not audition. All persons entering the contest venue will be required to sign a release.**

Dates and locations subject to change. Shining Star CLE, Mandel JCC, production personnel for the program, participating media, ad agencies, or any person or entity connected with the production, administration, or judging of the auditions or the program, or any of their respective parent companies, affiliates, subsidiaries, agents, or representatives are not responsible for and shall not be liable for (i) any failure of transportation, inaccurate directions, or inability for any reason to appear at an audition or performance or appearance before the judges; (ii) any injuries, losses, or damages of any kind caused by traveling to or from the audition venues, being present at the audition venues, participating in the audition process or being selector for or disqualified from the process and/or the show; or (iii) any printing, typographical, or technological errors in any materials associated with the audition process. **No weapons, alcohol, or non-prescription drugs will be permitted at any audition.**

## Schedules & Conflicts

Participation in the Competition requires a significant time commitment, so carefully consider whether you are willing and able to make this commitment. It is important that parents are consulted to check for any and all known school, family, extra-curricular and work commitments, as well as medical appointments, private lessons, college trips, etc. Upon request, religious accommodations will be considered by our artistic director.

## **Release**

This Agreement is personal to me and is not assignable by me, and any purported assignment by me shall be null and void ab initio. This Agreement, and the benefits and rights granted hereunder in whole or in part, are freely assignable by Mandel JCC, and any of its respective assignees and licensees. In particular, but without in any way limiting the foregoing, I understand and acknowledge that Mandel JCC may assign, license or otherwise transfer some or all of its rights in and in connection with the Competition to others. Nothing contained in this Agreement shall be deemed to constitute an employment relationship, joint venture, or partnership between Mandel JCC and Participant, nor shall I be deemed Mandel JCC's agent for any purposes. In addition, nothing herein shall be deemed to grant me, in any way, any ownership interest in the Competition whatsoever, or any ownership in or right to utilize or exploit, in any way, any trademarks or copyrights associated therewith. This Agreement constitutes the sole and entire agreement of the parties with respect to the subject matter contained herein and supersedes all prior and contemporaneous understandings, agreements, representations and warranties, both written and oral, with respect to such subject matter. If any term or provision of this Agreement is invalid, illegal or unenforceable in any jurisdiction, such invalidity, illegality or unenforceability shall not affect any other term or provision of this Agreement or invalidate or render unenforceable such term or provision in any other jurisdiction. This Agreement is binding on and shall inure to the benefit of the parties hereto and their respective successors and assigns. All matters arising out of or relating to this Agreement shall be governed by and construed in accordance with the internal laws of the State of Ohio without giving effect to any choice or conflict of law provision or rule (whether of the State of Ohio or any other jurisdiction). Any claim or cause of action arising under this Agreement shall be brought only in the federal and state courts located in Cuyahoga County, Ohio, and the parties hereby consent to the exclusive jurisdiction of such courts.

BY SIGNING, YOU ACKNOWLEDGE THAT YOU HAVE READ AND UNDERSTOOD ALL OF THE TERMS OF THIS AGREEMENT AND THAT YOU ARE GIVING UP SUBSTANTIAL LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE MANDEL JCC, AND THAT YOU HAVE HAD THE OPPORTUNITY TO SEEK COUNSEL FROM AN ATTORNEY AND WERE ENCOURAGED TO DO SO.
